2 **EU Member State government funding for non-governmental organisations – trends and developments 2011-2016**

2.1 **Overall amount of government funding**

Almost half of the budget for the association sector is from a public source, coming from communes, regions, departments, the state and social welfare bodies.

In 2011, the state, local communities and other public bodies paid € 42 billion to associations,¹ in 2012, € 34.3 billion were paid.²

80 % of associations do not receive any subsidies, "just 7% of associations receive 70% of all public subsidies".³

Ministries granted to associations € 1.2 billion of subsidies in 2011; € 1.8 billion in 2012;⁴ € 2.1 billion in 2013;⁵ € 2.1 billion in 2014;⁶ € 2 billion in 2015⁷ (last published data).

The amount of funding granted to associations is widely criticised, as is the fact that the associations most generously funded by the ministries are mainly organisations created upon the initiative of the government, directed by civil servants, or under administrative supervision. "Under the pretext of seeking more flexible management processes, the State disguises these new organisations under the association label, which further complicates control by French citizens or their representatives of the use of public funds."⁸

"Although associations working in training and education received nearly 30% of funds, 211 million euros in 2011, associations charged with social action for administrative staff occupy second place, since they were granted 14.7% of the entirety of funding, that is to say more than 100 million euros to improve the living conditions of public agents and their families, in particular in the areas of catering, housing, childhood and leisure, as well as helping them to face difficult situations".⁹

Associations have suffered the consequences of state and local community budgetary cuts in recent years.¹⁰ However, as the Commission of Inquiry of the French National Assembly (*Commission d'enquête de l'Assemblée Nationale*) underlines, the amount of tax expenditure for the benefit of associations increased considerably. According to the Commission of Inquiry, tax reductions, employment policies in terms of state-aided contracts (*contrats aidés*) and support for civil service contracts testify to a re-engagement of the state in new forms of intervention and support for associations.¹¹

According to estimates by the Citizen Associations Collective (*Collectif des Associations Citoyennes*), the decrease in percentages of public financing to associations is:¹²

Government funding for associations working in the area of immigration, asylum and integration decreased sharply from 2011 to 2015. On the contrary, it increased in the area of justice, solidarity and equality.

These figures show that associations which offer services receive the highest subsidies. This situation has not changed since 2012.¹⁹ The

advocacy association ‘France land of exile’ (*France Terre d’Asile*) occupied fifth place (€ 26,538,250) in 2011, but is no longer on the list of the 15 most subsidised associations.²⁰

2.3 Restrictions (or other changes) on NGO funding from other sources

Access to funding for non-governmental organisations (NGOs) has become broader since the modification of the Law of 1 July 1901 relating to the Contract of Association in 2014²¹ (see Section 1).

The High Council for community life proposed different measures to develop private funding of NGOs.²² The measures proposed aim to:

- 1) Facilitate the development of activities and, in particular:
 - (i) to support the development of revenue generating activities by realigning the relationship between revenue generating and non-revenue generating activities;
 - (ii) to raise the threshold of commercial tax liability for associations which have accessory revenue generating activities;
 - (iii) to remove the automatic tax link between VAT, corporation tax and the Territorial Economic Contribution (*Contribution Economique Territoriale*);

- (iv) to make compensation concerning the tax credit for competitiveness and employment (CICE) more equitable for associations for the amount of the rebate on wages tax and the methods for its application.

2) To create new conditions for the consolidation and development of the voluntary sector:

- (i) to facilitate the reinforcement of organisations' own funds; to adapt banking tools for associations (association status);
- (ii) to reinforce organisations' own funds by retaining surpluses;
- (iii) to facilitate project financing by loans between associations of the same group;
- (iv) to develop taxation adapted to time deposits;
- (v) to facilitate the creation of ethical funds by relaxing criteria for social enterprises or businesses;
- (vi) to secure mergers, divisions, partial contributions of assets on the legal level and the tax level.

3) To secure and develop public generosity and the patronage by companies:

- (i) to simplify the framework for appealing to public generosity;
- (ii) to remove the concept of a restricted circle of people (organisations not being considered as of general public interest when they work for the benefit of a restricted circle of people);
- (iii) to extend tax deductions for solidarity on wealth and donations made to recognised associations of public utility (*Associations Reconnues d'Utilité Publique*) (ARUP);
- (iv) to secure the sector by harmonising laws;
- (v) to develop participative financing;
- (vi) to support the emergence of innovating financing.

4) Other measures are:

- (i) to secure the exemption of the transport payment;
- (ii) to facilitate donations from bequests;

- (iii) to encourage patronage by small and medium-sized companies (SME);
- (iv) to reinforce the financing of projects with innovative banking tools: bank loans, bank stock for a specific mission;
- (v) to assign a part of unclaimed assets in bank accounts to development funds for the voluntary sector (Fonds de développement de la Vie Associative).
