- 1 The European Union Agency for Fundamental Rights (the Contracting Authority) is planning to award the contract referred to above. The procurement documents consist in the contract notice number 2017 / S 135-275920 published on 18/07/2017 referred to above, this invitation letter, Annex A – Tender Specifications, Annex A.1 – Technical Specifications, Annex B – draft Framework Contract and Annex C – Standard Submission Form.

This tender is divided into 30 lots. Tenderers can apply for one or for more lots.

- 2 You must submit your tender exclusively on paper in one original and 2 copies. The tender must be placed inside two closed envelopes addressed as indicated below. The inner envelope should be marked as follows: "CALL FOR TENDERS F-SE-17-T11 – NOT TO BE OPENED BY THE INTERNAL MAIL DEPARTMENT".

The inner envelope must also contain three sealed envelopes, containing the administrative documentation, the technical offer and the financial offer. Each of these envelopes must clearly indicate the content ('Administrative Documents', 'Technical Offer' and 'Financial Offer').

In addition you shall submit a text-searchable digital version of the offer in data storage devices such as USB flash drives (i.e. memory sticks). In case of discrepancies, the paper version takes precedence over the digital one.

The digital versions of the offers must be placed together with the paper versions inside the corresponding sealed envelopes.

5. The period of validity of the tender, during which tenderers may not modify the terms of their tenders in any respect, is 12 months from the date indicated in point 3.

6. Submission of a tender implies acceptance of all the terms and conditions set out in the procurement documents and, where appropriate, waiver of the tenderer's own general or specific terms and conditions. The submitted tender is binding on the tenderer to whom the contract is awarded for the duration of the contract.

- 8 Tenders will be opened at 10:30 hrs on 27/10/2017 at the contracting authority's address. A maximum of two representatives per tender can attend the opening of the tenders. For organisational and security reasons, the tenderer must provide the full name and ID or passport number of the representatives at least 3 working days in advance to: procurement@fra.europa.eu. Failing that, the contracting authority reserves the right to refuse access to its premises.
- 9 Contacts between the contracting authority and candidates or tenderers are prohibited throughout the procedure save in exceptional circumstances and under the following conditions only:

Before the date of receipt indicated in point 3:

Upon request, the contracting authority may provide additional information solely for the purpose of clarifying the procurement documents.

The contracting authority is not bound to reply to requests for additional information received less than six working days before the date of receipt of tenders indicated in point 3.

The contracting authority may, on its own initiative, inform interested parties of any error, inaccuracy, omission or any other type of clerical error in the text of the procurement documents.

Any additional information including that referred to above will be posted on fra.europa.eu/en/about-fra/procurement. The website will be updated regularly and it is the tenderer's responsibility to check for updates and modifications during the submission period.

After the opening of tenders:

If obvious clerical errors in the tender need to be corrected or confirmation of a specific or technical element is necessary, the contracting authority will contact the tenderer provided this does not lead to substantial changes to the terms of the submitted tender.

13 You will be informed of the outcome of this procurement procedure (award decision) by e-mail only. It is your responsibility to provide a valid e-mail address together with your contact details in your tender and to check this e-mail address regularly.

14 If processing your reply to the invitation to tender involves the recording and processing of personal data (such as your name, address and CV), such data will be processed pursuant to Regulation (EC) No 45/2001 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data. Unless indicated otherwise, your replies to the questions and any personal data requested are required to evaluate your tender in accordance with the specifications of the invitation to tender and will be processed solely for that purpose by the Contracting Authority. - 17 Within two months of notice of the award decision, you may launch an action for annulment of the award decision. Any request you may make and any reply from us, or any complaint for maladministration, will have neither the purpose nor the effect of suspending the time-limit for launching an action for annulment or to open a new period for launching an action for annulment. The body responsible for hearing annulment procedures is indicated in Section VI.4.1 of the contract notice.
- 18 The European Union Agency for Fundamental Rights has the task of raising awareness of fundamental rights, promoting equality between men and women and preventing discrimination on the grounds of race, ethnicity, religion, age, disability or sexual orientation (according to the Equality Directives). Tenderers should be familiar with the relevant legislation, and be aware that any tenderer who can be shown to have suffered legal sanction for discriminatory practices on any of the above grounds, without prejudice to the relevant provisions of the Financial Regulation, are liable to have their tender rejected.
- 19 The signature of the framework contracts with the successful tenderers is envisaged during the month of September in 2018.
