Subject:	2021-02 Amending Budget

# THE MANAGEMENT BOARD OF THE EUROPEAN UNION AGENCY FOR FUNDAMENTAL RIGHTS

## HAVING REGARD to:

- a) Management Board decision of 17 May 2019 on the Financial Rules applicable to the budget of the European Union Agency for Fundamental Rights, and in particular article 22 "[t]he Director may accept any donation made to the Agency [...]", and
- b) Article 34, of the same decision, "[*a*]*ny* amendment to the Agency, including the establishment plan, [...], shall be the subject of an amending budget adopted by the same procedure as the initial budget of the Agency, in accordance with the provisions of the constituent act and Article 32 of this Regulation";

#### WHEREAS:

 a) The Austrian Authorities contribute to the 2021 rent of the Agency's premises up to a maximum amount of €160,000. The second annual instalment amounting to €80,000 was received in August.

The Agency signed a partnership agreement with the Bulgarian National Statistics Institute for the period 2019-2021 for which the Agency will receive a maximum amount of  $\in$ 248,111 split in several instalments. Within this context an amount of  $\notin$ 62,027.75 was received in April.

Article 1

a) To adopt the Statement of revenue and expenditure for the European Union Agency for Fundamental Rights for the financial year 2021 – Amending budget Nr 2 as provided in Annex I.
