

Looking back at the Annual General Meeting of the Fundamental Rights Platform

On 2 October, the Agency hosted the Annual General Meeting 2023 of the Fundamental Rights Platform. More than 200 participants from 24 countries attended the online event. The participants, representing civil society organisations, European institutions and international organisations, discussed how to tackle the changing fundamental rights realities in the European Union. Thematic discussions included how to build civil society resilience, how to mainstream fundamental rights into the use of EU funds, tackling the fundamental rights impacts of climate change, and ensuring that advances in Artificial Intelligence respect fundamental rights. This bulletin explores the rights of the displaced children as they look for protection in the EU, and ways to safeguard their rights. 4th quarter announcements

On **12 October**, at the conference [Reclaim Our Civil Space! - Where do we stand with the European civil society strategy?](#), FRA gave a preview of the findings contained in its civic space report which was published on 18 October (see next item for more information). The conference marked the closure of the large 'Reclaim our civil space!' programme. The EEA and Norway Grants funded programme was run for over three years by 10 CSOs from eight countries: Bulgaria, Czechia, Hungary, Norway, Poland, Romania, Serbia and Slovakia. The project supported local organisations to build their capacities, facilitating cross-border networking, and connecting local and Brussels-based organisations with a view of bringing their concerns to the EU level.

On **18 October**, FRA published its report [Protecting civil society – Update 2023](#). The report includes four 'spotlight' chapters that focus on: strategic lawsuits against public participation (SLAPPs), migrant rights defenders and search and rescue at sea; participation for organisations representing groups at risk of exclusion; and on how can donors better support CSOs under pressure. The report reflects the views of almost 400 civil society organisations active in the field of human rights in the EU27 and Albania, North Macedonia and Serbia.

Online consultation on FRA's work on the rights of people with disabilities

The consultation invited the insights of stakeholders on the upcoming FRA report on political participation of persons with disabilities and on a project on protecting the fundamental rights of people with disabilities in institutions. Being Black in the EU: Experiences of People of African Descent report

On **25 October**, FRA released [Being Black in the EU: Experiences of People of African Descent](#). The report presents the findings of FRA's third large-scale survey on immigrants and the descendants of immigrants. The report reflects the experiences of discrimination and racism of almost 6,800 people of African descent in 13 EU Member States. FRA's findings support developing a better understanding of the experiences of people of African descent in the EU and promote action towards more equality and inclusion.

First CharterXchange event

SAVE THE DATE! On **11-13 December**, FRA will run the first CharterXchange event. The meeting will bring together civil society representatives, national human rights institutions, equality bodies and civil servants to discuss how better implementation of the EU Charter of Fundamental Rights can foster positive change and enhance access to rights.

New FRA releases 2023

On **7 November**, FRA will publish its 19th annual update on antisemitic incidents in EU. This report is the only annual source of data of this nature for the EU. The report reveals persistent gaps in the recording of antisemitism across Europe as countries continue to collect data differently or do not collect any data at all. This impedes efforts to effectively counter hatred towards Jews in Europe. While this report does not cover data from 2023, previous reports show events in the Middle East can lead to a rise in antisemitism in Europe.

In **December**, a new report looking at challenges and promising practices when supporting persons displaced from Ukraine “Local efforts to integrate displaced persons fleeing the Russian invasion of Ukraine” will be published.

In **December**, “Your rights matter: Experiences of discrimination and violence of people with disabilities” will be published.
