

Introducing FRA's new Director Sirpa Rautio



On 14 December, FRA's Management Board appointed Sirpa Rautio as the next Director of the EU Agency for Fundamental Rights. Sirpa Rautio is currently Director of the Finnish Human Rights Centre and Chair of the European Network of Human Rights Institutions. In 2017-2022, she chaired FRA's Management Board. She has served many years in international and regional human rights organisations such as the UN, the Council of Europe, the OSCE and the EU, working for human rights, democracy, and the rule of law.

"I am proud to be chosen as the head of this much-respected EU Agency. With human rights under pressure, I look forward to working closely with FRA staff and its Management Board in promoting, protecting and advancing human rights together throughout the EU", said Rautio.

Sirpa Rautio will take up her duties as of March 2024. Until then, Constantinos Manolopoulos, FRA's Head of Corporate Services Unit, will serve as interim Director.

Being Black in the EU: Experiences of People of African Descent



On 25 October, FRA published its report on [Being Black in the EU: Experiences of People of African Descent](#). The report presents the findings of FRA's third large-scale survey on immigrants and the descendants of immigrants. The report reflects the experiences of discrimination and racism of almost 6,800 people of African descent in 13 EU Member States. FRA's findings support developing a better understanding of the experiences of people of African descent in the EU and promote action towards more equality and inclusion.



Fleeing Ukraine: Implementing temporary protection at local levels



12 December, FRA published its report on [Fleeing Ukraine: Implementing temporary protection at local levels](#), that looks at the fundamental rights situation of the persons displaced from Ukraine as a result of the ongoing war. This report explores the measures taken to ensure access to housing, education, employment and healthcare in 26 cities and regional authorities across 12 EU Member States. Based on the information collected, the report identifies 12 priority actions and builds on FRA's bulletins and survey findings on experiences of people displaced from Ukraine.



Children in migration: fundamental rights at European borders



18 December, FRA and the Council of Europe published a [Joint Note on Children in migration: fundamental rights at European borders](#). While carrying out border control procedures, children as vulnerable persons with special needs require heightened protection. This Joint Note looks at the standards in place for duty bearers and necessary safeguards for children.



EU funds: Ensuring compliance with fundamental rights



19 December, FRA published its report on [EU funds: Ensuring compliance with fundamental rights](#). This report looks at how the strengthened EU funding conditions introduced in 2021 related to the EU Charter of Fundamental Rights and the United Nations Convention on the Rights of Persons with Disabilities can be upheld in practice. It analyses the potential role of national human rights institutions, ombudsperson institutions and equality bodies.
