# **JOB PROFILE**

1. Job Framework

Job Title: Personal Assistant to the Director

### 2. Job Content

The mission of the Director's office is to guide and manage the Agency, ensuring that its objectives and related tasks, set out in the founding Regulation, are achieved efficiently and effectively and in accordance with the direction given by the Management Board of the Agency.

#### **Functions and Duties:**

The jobholder will, under the direct supervision of the Director, contribute to the smooth administration of the Director's secretariat. He/she will have particular responsibility in the coordination and organisation of the Director's activities.

The responsibilities of the successful candidate will be:

- Assist in the overall administration of the Director's office, i.e. provide administrative support in managing priorities and work flows involving the Director, coordinating and monitoring multiple and diverse activities and work processes to ensure that Director's decisions are properly conveyed and carried out;
- Take responsibility for planning the Director's agenda with appropriate consultation; effectively prioritise and resolve related conflicts and competing demands; coordinate the attendance to the meetings of the Director;
- Serve as first point of contact and liaison with the Units; communicate on behalf of the Director and keep Units informed by conveying status updates and other relevant information; bring sensitive and urgent matters to the



attention of the Director; follow-up on commitments made and ensure timely collection and submission of documents to the Director (e.g. briefing notes, speaking points, meeting documentation, administrative files);

- Deal with incoming emails and letters (including registration of correspondence, routing to relevant staff, tracking of replies); draft written correspondence on behalf of the Director; screen phone calls, enquiries and requests, and handle them as appropriate;
- Organise and attend internal meetings, and draft minutes and action points; ensure the Director is well prepared and has all relevant documentation for such meetings;
- Organise external meetings on behalf of the Director, handling all necessary arrangements (e.g. room reservations, participant lists, meeting agendas, invitations, catering, seating arrangements, background documentation, technical equipment, greeting of high-level visitors);
- Organise the Director's missions (including travel arrangements, preparation of mission file, communication with external partners etc.)
- Devise and maintain office systems, including data management (e.g. Director's contacts) and filing (electronic and paper);
- Handle a wide range of administrative duties/processes (e.g. timesheets, travel arrangements, visa applications, mission reimbursements and other expense statements, office supply requisitions, conference room bookings).

## 3. Qualifications and experience required

## A. Eligibility criteria

Candidates will be considered for the selection phase on the basis of the following criteria to be fulfilled by the deadline for applications:

(a) A post-secondary education attested by a diploma<sup>1</sup> and, following the diploma, at least six (6) years of professional experience

OR

A secondary education attested by a diploma<sup>2</sup> giving access to post-secondary education and following this diploma, at least nine (9) years of professional experience;

(b)Thorough knowledge of one of the official languages of the European Union and a satisfactory<sup>3</sup> knowledge of another of the EU official languages<sup>4</sup>;

Furthermore, in order to be eligible candidates must:

- Be a citizen of one of the Member States of the European Union;
- Be entitled to his or her full rights as a citizen<sup>5</sup>;
- Have fulfilled any obligations imposed on him/her by the laws on military service:
- Be physically fit to perform the duties linked to the post<sup>6</sup>.

#### B. Selection criteria

Candidates selected on the basis of the above eligibility criteria will then be evaluated according to the following selection criteria, which must be clearly specified in the applicant's Europass CV.

#### **Essential**

- Minimum of 6 years professional experience in the area mentioned under "Functions and duties";
- Professional experience in a public administration;
- Professional experience of working with senior managers in a front office;
- Excellent English written and oral communication skills;
- Strong interpersonal, excellent organisational skills, and capacity to prioritise work effectively, dealing with multiple tasks and meeting tight deadlines;
- Proficiency in using MS Office software.

## Advantageous

The following characteristics will be considered as additional assets:

- Good command of German and/or French (level B2 and above);
- Professional experience in an intergovernmental organisation or EU body;
- Good knowledge of the EU administrative and financial procedures, or equivalent procedures in an intergovernmental body;
- Knowledge and experience in the area of fundamental rights;

Please note that due to the large number of applications we receive, the system may face problems in processing such amounts of data when reaching the deadline for submission of applications. We therefore advise to apply well ahead of the deadline.

FRA urges anyone meeting the eligibility criteria and interested in the position to apply. FRA is an equal opportunities employer and encourages applications without distinction on the basis of gender, colour, racial, ethnic or social origin, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, nationality, age, sexual orientation or gender identity.

#### **SELECTION PROCEDURE**

A Selection Committee is nominated by the Appointing Authority of FRA.

Eligibility of candidates will be assessed according to compliance with all formal requirements by the closing date for the submission of applications (please see 3.A. Eligibility criteria).

Only the applications of eligible candidates will be evaluated in accordance with the selection criteria as specified in the publication notice (see point 3.B). **The Agency will invite for an interview the top 8 candidates among those who have obtained at least 60%.** 

The selection procedure will be composed of an Interview and a written part. Both parts will be held in English. It will take place in Vienna (Austria), where the Agency has its seat and where the place of employment is.

Candidates invited to an interview will be requested to submit, on the day of the interview, a non-certified copy of their diploma(s) and evidence of their professional experience, clearly indicating the length and nature of their experience and whether full time or part time work. Prior to contract signature, the successful candidate/s will be requested to provide FRA with original or certified copies of all relevant documents proving the eligibility requirements.

Successful candidates will be included on a reserve list drawn up by the Selection Committee. This reserve list will be proposed to the Appointing Authority of FRA. The Appointing Authority will decide on the establishment on the reserve list. This reserve list will be valid from the date of its establishment (in year 'N') until 31 December of year 'N+5'. Its validity may be extended. The reserve list may be used for future recruitment, should vacancies arise. Each candidate will be informed by letter whether or not he/she has been placed on the reserve list. Candidates should note that inclusion on a reserve list does not quarantee recruitment.

On the basis of the adopted reserve list, the Appointing Authority of FRA may offer a contract of engagement.

Please note that the Selection Committee's work and deliberations are strictly confidential and that any contact with its members is strictly forbidden.

Due to the large volume of applications, the Agency regrets that only candidates selected for the interviews will be contacted. Applicants are invited to follow the recruitment process on the FRA website.



#### **ENGAGEMENT AND CONDITIONS OF EMPLOYMENT**

A temporary agent contract will be offered pursuant to Article 2(f) of the Conditions of Employment of Other Servants of the European Union for an indefinite period.

The successful candidate will be recruited in the grade AST 4. The basic monthly salary for the grade AST 4 (Step 1) is € 4,231.23. In addition to the basic salary, staff members may be entitled to various allowances, in particular a household allowance, expatriation allowance (16% of basic salary + household allowance), dependent child allowance and education allowance. The salary is subject to a Union tax deducted at source and it is exempt of national taxation.

FRA also offers a comprehensive **welfare package** including pension scheme, medical, accident and occupational disease insurance coverage, unemployment and invalidity allowance and travel insurance.

Moreover, FRA offers different opportunities of **schooling services** through service level agreements with international schools and pre-school establishments, and has introduced policies on **teleworking and flexitime** in its attempt to reconcile work and private life.

Under certain circumstances, in particular where staff members are obliged to change their place of residence in order to take up employment, the Agency may also reimburse various expenses incurred on recruitment, notably removal expenses.

## **DATA PROTECTION**

If the complaint is rejected, the candidate may bring a case under Article 270 of the Treaty on the Functioning of the European Union and Article 91 of the Staff Regulations of Officials and Conditions of Employment of Other Servants of the European Union before:

It is also possible to lodge a complaint to the European Ombudsman pursuant to Article 228(1) of the Treaty on the Functioning of the European Union and in accordance with the statute of the Ombudsman and the implementing provisions adopted by the Ombudsman. Before the Ombudsman can accept a complaint, it is necessary that the complaint is first addressed to the Agency.
